Background

China and Africa have a history of trade relations, sometimes through third parties, dating back as far as 202 BC and AD 220. However, the establishment of modern Sino-African relations dates back to the late 1950s when China signed the first official bilateral trade agreement with Algeria, Egypt, Guinea, Somalia, Morocco and Sudan. It is not precisely known when China and Ethiopia first made direct contact. The People's Republic of China–Ethiopia diplomatic relations were established in 1970. Currently, Ethiopia has an embassy in Beijing and the People's Republic of China has an embassy in Addis Ababa. Ever since 2006 China has become Ethiopia's largest trading partner. In addition to the embassy in Beijing, Ethiopia has a Consulate General in Guangzhou, Chongqing and Shanghai that help to facilitate trade and other economic relations between the two countries. The bilateral trade volume between Ethiopia and China has reached 2.19 billion dollars.

China is expanding its investment in Ethiopia and Africa at large. Those who support the investment of China in Africa argue that "... the recent increase in Africa's gross domestic product is because of Chinese investment. The roads, bridges, and dams built by Chinese firms in Africa are low cost, good quality, and completed in a fraction of the time." Unconditional and low-rate credit lines (rates at 1.5% over 15 years to 20 years) have taken the place of the more restricted and conditional Western loans. Since 2000, more than \$10bn in debt owed by African nations to the PRC has been canceled. China has been engaged in a kind of "health diplomacy" towards Africa since the 1960s. Besides there has been a range of multifaceted areas of cooperation and support in cultural exchange, military peacekeeping cooperation and so on. These all shows the exponential growth in China-African cooperation.

Amongst of all mentioned above and to facilitate the tie, the Chinese government has been giving a series of seminars and trainings to officials drawn from developing countries. The seminars and trainings focused on entry-exit commodity inspection, import-export trade procedures, inspection and quarantine procedures as well as on a range of other development issues with the aim of partly in cognizant with the transparency principle of the SPS agreement of the WTO to all member states and partly to help strengthen development endeavors in developing countries in the aforementioned areas and upscale the relation to a higher level. One such seminar was undertaken from 07 - 27 July, 2015 in Changzhou, Jiangsu province of the Peoples Republic of China.

Introduction

The relation between China and African countries is getting strength year after year. China is becoming one of the crucial trade partners with African countries. China is generously sharing its experience in its development journey with developing countries to create unconditional, sustained and mutual benefiting relation.

Every year China has been providing short term trainings and seminars on various aspects for developing countries between months July and November. As part of the annual program a 21 days seminar for inspection and quarantine officials of English speaking African countries was held recently from 07 - 27 July, 2015. This seminar was sponsored by the Ministry of Commerce of the Peoples' Republic of China and organized by the General Administration of Quality Supervision, Inspection and Quarantine (AQSIQ). The seminar was facilitated by the Jiangsu Inspection and Quarantine Institute of Quality (JSIQ). Such kinds of seminars and workshops deepen the relation and trade ties of Peoples Republic of China with other developing countries.

JSIQ is an affiliate of the Jiangsu Entry-Exit Inspection and Quarantine Bureau as an independent legal entity, and also the International Communication and Co-operation Base directly under General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China (AQSIQ). It is a comprehensive scientific research institution which integrates international communication, quality research, comprehensive training, administration and consultation.

JSIQ started to facilitate the human resource foreign aid training programs of the Ministry of Commerce since September 2006, and had successfully undertaken 62 foreign aid training programs concerning quality inspection by 2014. The medium of communications that were used in class included English, French and Mandarin. According to the JSIQ, totally 1500 officials and technicians from 125 countries of 5 continents have participated in such foreign aid training programs.

Objectives

The general purpose of the seminar was to enhance an acquaintance with African countries, establishing a cooperation stage between other developing countries, promoting the economy and trade cooperation with developing countries. The specific objectives of the training were to:-

- Aware participants about the strict regulatory procedures concerning inspection and quarantine for imports in to PRC
- Highlight China's import and export commodity inspection and quarantine system
- Introduce participants with Chinese import-export inspection and supervision procedures for light industrial products
- Describe food safety control and food contact materials regulations of China
- Discuss on quality issues of Chinese industrial products and help participants understand China's crackdown to control counterfeit products
- Make participants understand about Chinese culture and history

Seminar organization and participants

The seminar was entitled "Seminar for Inspection and Quarantine Officials of African Countries", and lasted from July 7th to July 27th, 2015. The language used in class was English. It was sponsored by the Ministry of Commerce of the PRC and organized by General Administration of Quality Supervision, Inspection and Quarantine of PRC (AQSIQ) and is undertaken by Jiangsu Inspection and Quarantine Institute of Quality (JSIQ). Jinling Mingdu Hotel provided accommodation and other daily services for the participants in Changzhou city during the seminar.

For this seminar twenty five (25) inspection and quarantine officials were drawn from ten (10) English speaking African countries, (Annex II). Two Ethiopian delegates from the Ministry of Agriculture participated in this round of seminar. With just only a week difference in the program, another round of seminar for Entry-Exit Animal and Plant Quarantine officials for developing countries had been held practically with same itinerary. In that same seminar three Ethiopian participants from the Ministry of Agriculture were present. Hence this report also reflects the activities and participation of our colleagues who participated in the other round. Thematic presentation topics at the seminar

The seminar covered a wide range of activities including special subject lectures, symposium and discussions, field trips, investigation and practice. During the seminar for inspection and quarantine officials of African countries various papers were presented by high level government officials and scholars from AQSIQ, JSIQ and CIQ. The presenters introduced participants with policies and measures involved in China's social and economic development and other information related to the themes of the seminar courses. Most of the presenters used the Mandarin language hence participants had to use the services of translators from the JSIQ. The seminar was successfully executed based on the program itinerary (Annex I). The topics covered were:-

- About china: Brief introduction to Chinese culture
- An Overview on China Inspection and Quarantine (CIQ) system
- An overview of China's import and export commodity inspection and quarantine

- An overview of China's import and export commodity inspection and quarantine
- Introduction to Inspection and Supervision on Chinese Import-Export Textile & other light industry Products
- Introduction on inspection business based on inter-governmental agreements
- Introduction to Inspection and Supervision on Import & Export Mechanical and Electrical Products
- Introduction to Laws and Regulations on Chinese Import & Export Animal (Plant) and Animal (Plant) Products Inspection
- Introduction on Entry-exit Health Quarantine in China
- Testing of Food Packaging and Food Contact Material
- Food safety control in China
- Introduction on China's foreign quality inspection cooperation

Country reports

The seminar also created a platform for advanced experience sharing in inspection and quarantine fields for all participating countries. Delegates delivered country specific presentations to introduce their inspection and quarantine work as well as briefed about the economical, cultural and historical realities of their countries. The presentation from Ethiopia was organized and delivered by Ato Teshager Abebaw and Dr. Elias Walelign both from Ministry of Agriculture. The content of the Ethiopian country report was entitled "An Overview of the Entry-Exit Agricultural Products Inspection and Quarantine Situation of the FDR Ethiopia". The report included two themes.

✓ Brief Introduction: Ethiopia the land of wonders, the past and the present! (By Teshager Abebaw)

This part of the presentation discussed about the nation's history, politics, people, economy, culture, tradition, values, various development initiatives and other features of the country to create awareness on the represented country delegates and Chinese colleagues.

✓ An overview of the Entry-Exit commodities inspection and quarantine Situation of the FDR Ethiopia (By Elias Walelign)

This part of the presentation discussed about the organizational structure of the animal and/or plant regulatory authorities, legal basis of inspection and quarantine, overview of current animal and plant inspection and quarantine systems, agricultural products Import/export from/to PRC, Concerns on Chinese Imported commodities.

Places visited

1- Changzhou City, Jiangsu province, China

Changzhou Entry-Exit Inspection and Quarantine Bureau



Visit Changzhou Museum and Urban Planning Exhibition Hall

Changzhou Museum and urban planning Exhibition hall is found at the heart of Changzhou city. It contains collections from the past, the present and it indicates where the city is heading in the future. It preserves the history and aspires the future so that the future generation will know its historic root.



Tianning Temple

The Tianning Temple, located in Changzhou City, Jiangsu Province, China, is noted for its giant wooden pagoda, the Tianning Pagoda. With 13 stories and a height of 153.79 meters (505 ft), this wooden pagoda is now the tallest pagoda in the world. Although the existing pagoda was built by April 2007, the temple grounds and the pagoda have a history of construction and destruction for the past 1,350 years, since the time of the Tang Dynasty (618–907).

The Tang Dynasty and the terracotta warriors

Lessons learned

- The participants learned about the actual situation of Chinese inspection and quarantine and it also helped Chinese authorities about the inspection and quarantine situation of African countries
- Participants also were able to understand the working procedures, laws and regulations, as well as the inspection of textile products, electrical and mechanical products of China.
- Also, the entry-exit animal and plant quarantine, entry-exit health quarantine, food safety control systems of China have been understood

- Above all, that to facilitate trade, all countries must continuously improve on the capacity for inspection and quarantine procedures for imports and export to protect the health and safety of humans, protect plant and animal life as well as the environment
- In addition to the lectures, the tours and cultural experiences gave participants real image of the developing China and glimpse of its cities landscapes, people, culture and tradition.

Closing remarks

The seminar for Inspection and Quarantine officials of African countries came to an end after 21 days of class presentation and field trips. During the closing ceremony, final vote of thanks was presented by the officials of inspection and quarantine agencies of African countries consequently representatives from the organizing institutions of AQSIQ and JSIQ made closing remarks. Finally, participants received certificates for successful completion of the seminar and the seminar was closed up.
